TEST COMMENTS:

This is a no-till site planted early in May following a rye cover crop. The site started well with good early-season growing conditions. Below-average rains from July on took a toll on the yield of some of the earlier hybrids. Any difference in soil water holding capacity showed up within the plot at harvest with yield variability. There was also some amount of deer damage within the plot at harvest.

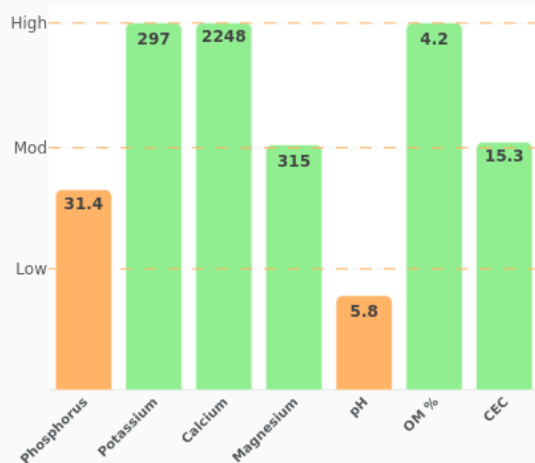

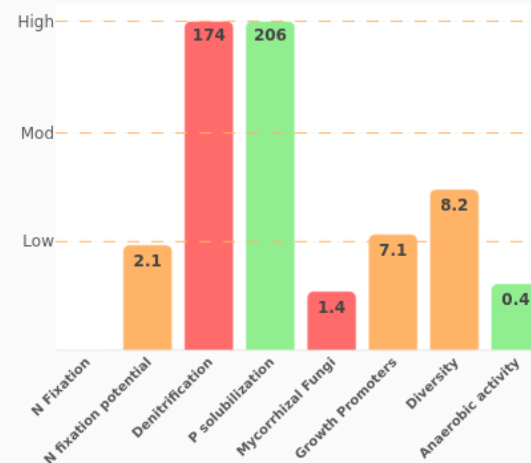

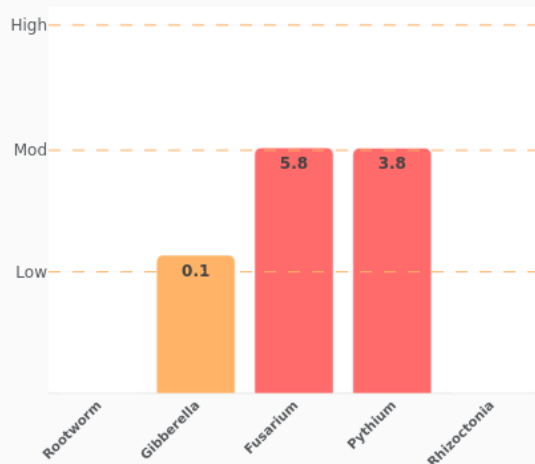
