*This plot was planted in early May under somewhat dry conditions and received no rain for the first 13 days after planting, which delayed emergence. By mid-June, when stand counts were taken, rainfall had become consistent with good accumulation, giving the corn the boost it needed. Stands were excellent! At harvest, some tar spot was observed, but the corn was tall with virtually no lodging. Ears were well developed with only minor tip-back on a few hybrids. A strong plot overall!*
